Museum Blvd. Wichita, KS 67203) which damaged more records. The Wagonamsters appointed me in as Purser (Treasurer) to pay bills and maintain records in one location. This non profit civic group barely breaks even each year from dues and assessments. Any cash in the checking account is from the Wagonmasters Downtown Chili Cook off – an annual all volunteer event with net proceeds paid out to deserving scholarship recipients and other local charities. Any penalty of this size would cause one of Wichita's finest civic groups to terminate its existence. With the appointment of a CPA as Purser, the organization is catching up on all its reporting responsibilities and organizing its records in a permanent location.
