DECLARATION RE FILING RETURN(S) LATE

Rick Smith hereby states and declares as follows under the penalties of perjury:

- 1. I am the president of the Yakima Southwest Rotary Club for the 2009-10 Rotary Year (July 1 to June 30).
- 2. About one week ago I learned for the first time that no Form 990 returns may have been filed for our Rotary Club for the 2006-7 and 2007-8 Rotary Years, and further, that no return was filed for the 2008-9 Rotary Year.
- 3. The Club Treasurer and CPA, Julie Smith, during the first two of those Rotary Years and a portion of the third year (she resigned her membership earlier this year) advises us that she prepared and filed returns for the 2006-7 and 2007-8 Rotary Years and has receipts to evidence that she did so, but she has not provided them to me as yet. I understand that the IRS has no record of having received those returns.
- 4. During the above time frame, Ms. Smith left the accounting firm with which she had been associated for several years and became an in-house accountant with a local medical clinic and more recently, I understand, with a local fruit company. It was sometime during these transitions that she should have prepared the return for the 2008-9 Rotary Year and, if necessary, the two previous Rotary Years, but she overlooked doing so, I believe, because of the changes which were occurring in her professional life.
- 5. Until about one week ago, neither I nor anyone else in our Rotary Club, to my knowledge, was aware of Ms Smith's failure to ensure the timely filing of a return for the 2008-9 Rotary Year or, if she failed to do so, for the two previous Rotary Years. Upon learning of this, I acted promptly to have returns prepared for all three years, which are filed herewith.
- 6. Attached to the Form 990 for each year is my letter explaining other circumstances having to do with our Rotary Club and the impact an imposition of late filing penalties will have on our Club's community service activities. By this reference, I am incorporating my letter into this Declaration.
- 7. I respectfully request that the circumstances which I have described in this Declaration and my referenced letter be deemed reasonable cause for the late filing of the return for the 2008-9 Rotary Year and for the two previous Rotary Years should it be determined that no returns were filed for those years as well.
