

BY-LAWS OF THE SHOR FAMILY FOUNDATION, INC.

ARTICLE I CORPORATE PURPOSE

The Corporation is formed for (1) the express purpose of providing funding to non-profit organizations involved in the following areas of focus: Education, Parenting, Social and Racial Equality, Promotion of Visual and Performing Arts, and the Sharing of Knowledge through Information Technology. Organizations must meet the criteria described in the attached narrative to be eligible to qualify for funding (2) any other activities prescribed under section 501(c)(3) of the Internal Revenue Code.

It is the express intent of the founders of this corporation that the corporation qualify for tax-exempt status under IRC 501(c)(3) and any amendments or modifications thereto. Accordingly and as more specifically outlined at Article VIII and Article IX herein, no part of the net earnings of the corporation shall inure to the benefit of any private member, shareholder, trustee or any other individual having a personal or private interest in the activities of the corporation.

The corporation and any individual on behalf of the corporation is specifically prohibited from attempting to influence legislation as a substantial part of the corporation's activities, and no individual on behalf of the corporation may participate in campaign activity for or against political candidates

The corporation seeks to satisfy the requirements of IRS Section 508(e) through the statutes set forth by the State of New Jersey that expressly apply to the corporation.

## ARTICLE II. NAME, SEAL AND OFFICES.

1. Name. The name of this Corporation is "The Shor Family Foundation, Inc."

2. Seal The seal of the Corporation shall be circular in form and shall bear on its outer edge the name of the Corporation and in the center, in words and figures, "Corporate Seal, New Jersey, 2010." The Trustees may change the form of the seal or the inscription thereon at pleasure.

3. Offices The principal office of the Corporation shall be 750 Hope Road, Tinton Falls, New Jersey 07724. The Corporation may also have offices at such places as the Trustees may, from time to time, appoint or as the purposes of the Corporation may require within or without the State

## ARTICLE III. TRUSTEES.

1. Qualification, Number and Term. There shall be four (4) Trustees who shall manage and control the business and property of the Corporation. The Four Trustees shall be the existing members of the Shor "immediate family" Otniel Shor, Elaine M. Shor, Jonathan D. Shor and Talia R. Shor (also hereinafter referred to as "founding trustees"). The term of the founding Trustees shall be two (2) years. At the expiration of the term of the trustee, an election shall be held pursuant to the terms of paragraph 2 of this article. The subsequent terms shall be as follows founding trustees two (2) years, all other elected trustees one (1) year. To qualify as a trustee, an individual must be at least twenty one (21) years of age.

2. Election of Trustees. The Trustees shall be elected by a simple majority of the

votes cast by the members. A vote of the members shall take place thirty (30) days prior to the second anniversary of the election of the Trustee(s). No Trustee shall be subject to any term limitations regarding their position as Trustee.

3. Resignation or Removal. Any Trustee may resign at any time by giving written notice of such resignation to the Board of Trustees. Any Trustee, on written notice of meeting specifying the action proposed, may be removed at any time, by a simple majority of the votes cast by the members having the right to vote thereon for the continued inattention to the duties of the Trustees or for doing any act which would put the Corporation in violation of the laws establishing its charitable and tax-exempt character

4. Vacancies. Any vacancy occurring in the Board of Trustees during the year, including the vacancy created by an increase in the number of Trustees made by the Board of Trustees, may be filled for the unexpired term of the office which has become vacant or, if the vacancy has been created by an increase in the number of Trustees, for such initial term not to exceed two (2) years as the Trustees may establish. Such vacancies shall be filled by the majority vote of the remaining Trustees having the right to vote thereon, even though the remaining Trustees shall consist of less than a quorum of the entire 'body

5. Annual Meeting. The Trustees shall meet annually on the second Tuesday in September of each year, starting in 2010, at the principal office of the Corporation or at such other place or at such other time, not in excess of thirty (30) days from the second Tuesday in September of each year, which the Chairman shall decide on notice given in the manner hereinafter set forth.

6. Special Meetings. Special meetings of the Board of Trustees may be called by the

President or Vice-President and must be called by either of them upon the written request of any member of the Board.

7. Notice of Meeting. Notice of all Trustees' meetings, except as herein otherwise provided, shall be given at least three (3) days prior to said meeting and may be given by mail, by telephone or by facsimile to the usual business or resident address of the Trustee, but such notice may be waived by any Trustee. Regular meetings of the Board of Trustees may be held without special notice at such time and place as may be determined by the Board. At any meeting at which every Trustee is present, without notice or waiver thereof, any of the Corporation business may be transacted except for those matters requiring previous written notice.

8. Chairman. At all meetings of the Board of Trustees, the President or Vice-President, or in their absence a chairman chosen by the Trustees present, shall preside.

9. Quorum. Except as otherwise provided in these By-Laws, at all meetings of the Board of Trustees a majority of the Trustees shall be necessary and sufficient to constitute a quorum for the transaction of business and the act of the majority of Trustees present at any meeting at which there is a quorum shall be the act of the Board of Trustees. If at any meeting there is less than a quorum present, the majority of those present may adjourn the meeting from time to time without further notice to any absent Trustee.

10. Contracts and Services. In the ordinary transaction of the business of the Corporation, no Trustee nor any business association or organization with which a Trustee may be associated shall be disqualified to furnish goods or services to the Corporation, provided that the furnishing of said goods or services is at a price no greater than their ordinary market price and is not contrary to the proscriptions of the Certificate of Incorporation or is a prohibitive

transaction which would result in the denial of the tax exemption under Section 503 or Section 507 of the Internal Revenue Code and its regulations as they now exist or may hereafter be amended. No contract for goods or services shall be entered into except by the authority of the Board of Trustees and shall be under the hand of any two Trustees.

11. Powers. All the corporate powers except as are otherwise provided for in these By-Laws and in the laws of the State of New Jersey shall be and are hereby vested in and shall be exercised by the Board of Trustees. The Board of Trustees may, by general Resolution, delegate to committees of its own members and to officers of the Corporation such powers as they may see fit.

12. Funding. From time to time the Trustees shall provide financial support to eligible organizations that promote, Education, Parenting, Social and Racial Equality, Advancement of Visual and Performing Arts, and the Sharing of Knowledge through Information Technology. Organizations must meet the criteria described in the attached narrative to be eligible to qualify for funding. The determination of the organizations that shall receive such financial support shall be determined by the Board of Trustees. No decision for the provisions of financial support shall in any way be limited to or include reasons of race, religion, color or creed. The Trustees may, from time to time, make a general appeal to the public for funding, which said funds shall become a part of the financial support provided as set forth herein. The arranging of any competition for the awarding of such financial support shall be under the supervision of a committee consisting of members of the Board of Trustees and of such other members as the President may appoint.

#### ARTICLE IV OFFICERS

1. The Officers of the Corporation shall be the President, Vice-President, Secretary, Treasurer and such other officers, with such powers and duties not inconsistent with these By-Laws as may be appointed and determined by the Board of Trustees. Any two offices except those of President and Vice-President may be held by the same person.

2. Election, Term of Office and Qualifications. The President shall be elected annually by the Board of Trustees from among its qualified members, and the other officers shall be elected annually by the Board of Trustees from among such persons as the Board of Trustees may see fit, at the annual meeting of the Board of Trustees.

3. Vacancies. In case any office of the Corporation becomes vacant by death, resignation, retirement, disqualification or any other cause, the majority of the Trustees then in office, although less than a quorum, may elect an officer to fill such vacancy, and the officer so elected shall hold office and serve until the next annual meeting of the Board of trustees and until the election and qualification of his successor.

4. President. The President shall preside at all meetings of the Board of Trustees. He shall have and exercise general charge and supervision of the affairs of the Corporation and shall do and perform such other duties as may be assigned to him by the Board of Trustees.

5. Vice-President. At the request of the President or in the event of his absence or disability, the Vice-President shall perform and possess and exercise the powers of the President, and to the extent authorized by law, the Vice-President shall have such other powers as the Board of Trustees may determine and shall perform such other duties as may be assigned to him by the Board of Trustees.

6        Secretary The secretary shall have charge of such books, documents and papers as the Board of Trustees may determine and shall have the custody of the Corporate Seal He shall attend and keep the Minutes of all meetings of the Board of Trustees. He may, with the President or Vice-President or Treasurer, sign in the name and on behalf of the Corporation any contracts or agreements authorized by the Board of Trustees and when so authorized or ordered by the Board of Trustees, he may affix the Seal of the Corporation. In the Secretary's absence, and so long as the Board of Trustees has not ordered the use of the Seal of the Corporation, any Trustee may sign on the Secretary's behalf along with the President or Vice-President or Treasurer as provided for above, contingent that at least two distinct persons participate in the signing He shall in general perform all duties incident to the office of Secretary, subject to the control of the Board of Trustees and shall do and perform such other duties as may be assigned to him by the Board of Trustees.

7.        Treasurer. The Treasurer shall have the custody of all funds, property and securities of the Corporation, subject to such rules and regulations as may be imposed by the Board of Trustees He may be required to give bond for the faithful performance of his duties in such sum, with such sureties as the Board of Trustees may require When necessary or proper he may endorse on behalf of the Corporation for collection checks, notes or other obligations and shall deposit the same to the credit of the Corporation at such bank or banks or depository as the Board of Trustees may designate. He shall sign all receipts and vouchers and together with such other officer or officers, if any, as shall be designated by the Board of Trustees by Resolution, he shall sign all checks of the Corporation and all bills of exchange and promissory notes issued by the Corporation, except in cases where the signing and execution thereof shall be expressly designated by the Board of Trustees by Resolution, or by these By-Laws, to some other officer or

agent of the Corporation. He shall make such payments as may be necessary or proper to be made on behalf of the Corporation. He shall enter regularly on the books of the Corporation, to be kept by him for the purpose, a full and accurate account of all monies and obligations received and paid or incurred by him for or on account of the Corporation and he shall exhibit such books at all reasonable times to any Trustee on application at the offices of the Corporation. He shall, in general, perform all the duties incident to the office of Treasurer, subject to the control of the Board of Trustees.

8. Salaries. It is anticipated that the services of all officers will, for the most part, be voluntary; however, when money may be available from any general and undedicated funds, the Board of Trustees may fix salaries for all officers reasonable in amount and the fact that any officer is a Trustee or member of an advisory committee shall not preclude his receiving a salary or voting on the Resolution providing for the same.

9. Removal. Any officer may be removed from office by the affirmative vote of two-thirds (2/3rds) of all the Trustees at any regular or special meeting called for that purpose, for non-feasance, malfeasance or misfeasance, for conduct detrimental to the interests of the Corporation, for lack of sympathy with its objects or refusal to render reasonable assistance in carrying out its purposes. Any officer proposed to be removed shall be entitled to at least five (5) days' notice in writing by mail of the meeting of the Board of Trustees at which such removal is to be voted upon and shall be entitled to appear before and be heard by the Board of Trustees at such meeting.

#### ARTICLE V. ADVISORY COMMITTEE.

The Board of Trustees may appoint from its number or from such persons as the Board may see fit, one or more advisory committees and at any time may appoint additional members thereto. The members of any such committee shall serve at the pleasure of the Board of Trustees. Such advisory committee shall advise with and aid the officers of the Corporation in all matters designated by the Board of Trustees. Each such committee may, subject to the approval of the Board of Trustees, prescribe rules and regulations for the call and conduct of meetings of the committee and other matters relating to its procedure. The members of any advisory committee shall not receive any compensation for their services as such but shall be recompensed for all personal money for expenses which they may have been authorized to advance in carrying out the business of the Corporation.

#### ARTICLE VI. VOTING UPON SHARES OF OTHER CORPORATIONS

Unless otherwise ordered by the Board of Trustees, the President shall have full power and authority on behalf of the Corporation to vote either in person or by proxy at any meeting of shareholders of any corporation in which this Corporation may hold shares and at any such meeting may possess and exercise all the rights and powers incident to the ownership of such shares which as the owner thereof this Corporation might have possessed and exercised if present. The Board of Trustees may confirm like powers upon any other person and may revoke any such powers as granted at its pleasure.

#### ARTICLE VII. FISCAL YEAR.

The fiscal year of the Corporation shall commence on January 1 of each year and end on December 31 of the same year.

## ARTICLE VIII INVESTMENTS.

The Corporation shall have the right to retain all or any part of any securities or property acquired by it in whatever manner and to invest and reinvest any funds held by it according to the judgment of the Board of Trustees, without being restricted to the class of investments which a Trustee is, or may hereafter be, permitted by law to make or any similar restrictions, provided, however, that no action shall be taken on behalf of the corporation if such action is a prohibited transaction which would result in the denial of the tax exemption under Section 503 or Section 507 of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended

## ARTICLE IX PROHIBITION AGAINST SHARING IN CORPORATE EARNINGS.

No member, Trustee, Officer or employee of, or committee of, or person connected with the Corporation or any other private individual shall receive at any time any of the net earnings or pecuniary profit from the operations of the Corporation, provided that this shall not prevent the payment to any such person of such reasonable compensation for services rendered to or for the Corporation in effecting any of its purposes as shall be fixed by the Board of Trustees; and no such person or persons shall be entitled to share in the distribution of any of the corporate assets upon the dissolution of the Corporation. All persons connected with the Corporation shall be deemed expressly to have consented and agreed upon such dissolution or winding up of the affairs of the Corporation, whether voluntary or involuntary, that the assets of the Corporation, after all debts have been satisfied, then remaining in the hands of the Board of Trustees shall be distributed, transferred, conveyed, delivered and paid over in such amounts as the Board of Trustees may determine, or as may be determined by a Court of competent jurisdiction upon

application of the Board of Trustees, exclusively to charitable organizations which would qualify for such distribution under the provisions of the Certificate of Incorporation of this Corporation and/or the Corporate By-Laws..

#### ARTICLE X. AMENDMENTS.

The Board of Trustees shall have power to make, alter, amend and repeal the By-Laws of the Corporation by the affirmative vote of three-fourths (3/4ths) of its number, provided, however, that the action is proposed at a regular or special meeting of the Board held on written notice, in which the notice of the proposed action has been inserted, and adopted at a subsequent regular or special meeting on like notice not less than two weeks subsequent to the meeting at which the action was proposed.

#### ARTICLE XI. MEMBERSHIP INTERESTS.

The initial founding members of the corporation shall be Otniel Shor, Elaine M. Shor, Jonathan D. Shor and Talia R. Shor. Thereafter, "blood relatives" of Otniel Shor, Elaine M. Shor, Jonathan D. Shor and Talia R. Shor may be added as members of the corporation at any time. Non "blood" relatives of Otniel Shor, Elaine M. Shor, Jonathan D. Shor and Talia R. Shor may be added as members of the corporation upon unanimous vote of the members. Additional qualifications for a membership interest shall be determined by the trustees on a case by case basis. No member shall be eligible to vote on corporate matters until he/she attains the age of twenty-one (21). Membership interests are non-transferable.
