Applicant must submit an essay with his/her application. See attached application form for more information on the essay. Please note that the essay is a critical component of the selection process.

TIER 3 - Eligibility Verification

Scholarship awards will be conferred when the following conditions are verified. Post-secondary school verifies that student has been accepted or is enrolled full-time.
