28 Small Business Development Programs In our third year of operation, 2007, the Working World made thirty nine productive projects with small, democratic enterprises and financed them with low interest loans with a success rate of over 99%. We met our goals of almost doubling the number of loans given in 2006 and more than doubling the amount loaned while keeping costs on par with 2006 and achieving a higher repayment rate. Our maturation process has thus far continued with great success fiscally and objectively. The projects funded include anything which could increase the capital of the enterprise, whether financial, human, or social, and produce sufficient income from the project to at minimum repay the loan, interest, and associated costs, including labor. The selection process involves a double bottom line, where we measure the projected yield in financial benefit to the cooperative with a project business plan, and also measure the social profit which can include such countable parameters as income enhancement (especially when raising above the poverty line) and increased employment, and more abstract variables such as capacitation, or even increases in social trust and cooperation. Over 99% of the loans made their plans plan to pay back and substantially increased the capital of their enterprise in all three categories, financial, human, and social. Projects included working capital for raw material to meet existing demand, new machines to produce new products including machines to recycle plastic via milling or melting, infrastructure upgrades including gas installations for a balloon cooperative, and even an entirely new factory for a shoe cooperative. All these loans improved the financial fortunes of the microenterprises, and in most cases resulted in a substantial increase in production and employment.
