the implementation of projects that include provision of drinking  
water, hygiene education, and sanitary latrines. The Organization  
works with the NGOs in some of the poorest communities in the world to  
support sustainable, community-managed solutions to water supply and  
sanitation problems. During 2008, the Organization and the local NGOs  
completed 53 water systems in three countries, benefiting over 6,000  
people. The Organization has completed 168 water systems benefiting  
over 26,000 people since inception. In addition, the Organization  
initiated a project in Ethiopia that will benefit over 4,000 people  
upon completion in 2009.

In addition, key staff members such as program directors and the director of outreach and education should have the opportunity to review income and expense reports for the whole organization.

The Board finance Committee, headed by the Board treasurer, reviews the financial reports and presents them to the full board. To help the board fulfill its oversight function, the Executive Director and the finance committee present the information in as clear and concise a manner as possible.
