

REASON FOR DELAY IN FILING PRIVATE FOUNDATION RETURNS

PAUL C. LYON, JR. IS THE CHAIRMAN OF THE PAUL AND RUTH LYON FAMILY FOUNDATION AND HAS BEEN SINCE THE FOUNDATION WAS FOUNDED ON DECEMBER 15, 2005. MR. LYON IS ALMOST 92 YEARS OLD. HE WILL SHORTLY BE RELIEVED OF HIS TITLE AND RESPONSIBILITIES BECAUSE OF HIS AGE AND MENTAL STATE. FAMILY MEMBERS BEGAN TO NOTICE A DECLINE IN HIS MENTAL COMPETENCY BETWEEN TWO AND THREE YEARS AGO. SINCE THAT TIME, HIS MEMORY HAS PROGRESSIVELY BECOME MUCH WORSE. HEALTH PROFESSIONALS HAVE UNOFFICIALLY DIAGNOSED HIM AS HAVING SENILE DEMENTIA. AT THE TIME THE FOUNDATION WAS FORMED IN 2005, THREE BOARD MEMBERS WERE INSTALLED. MR. LYON DID NOT SHARE ANY DETAILS OF THE FOUNDATION'S FINANCIAL SITUATION, INCLUDING THE FILING OF TAX RETURNS. WE BELIEVE THAT THE REASON HE FAILED TO FILE THE RETURNS FOR 2007 AND 2008 IS THAT HE SIMPLY DID NOT REMEMBER. IT IS ALMOST CERTAIN THAT HE DID NOT HAVE THE CAPACITY TO FILL OUT THE FORMS. THE REST OF THE BOARD MEMBERS, AS WELL AS THE ATTORNEY WHO DREW UP THE DOCUMENTS, FIRST LEARNED IN JANUARY, 2010 THAT THE RETURNS HAD NOT BEEN FILED AND MADE ARRANGEMENTS TO HAVE THEM COMPLETED.
