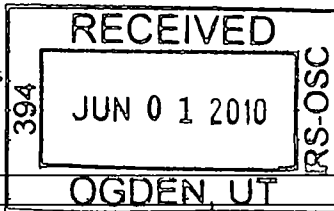



**Statement of Program Service Accomplishments**

During 2008, we planned, filmed, edited and completed Anthem, a feature length documentary film. In the film, our team travels the country to interview 7 ordinary people using their God given talents and passions to make a difference in their communities.

Our team conducted over a dozen test screenings of Anthem during the Fall and Winter with groups of college students, young adults, and the staff at Flannel, Inc., makers of the Nooma & BASIC film series. These screenings were used as opportunities to receive feedback for the final edits of the film.

Using a shorter cut of the film we created a live event to share with students and young adults.
