The organization's primary purpose is:

- to support and conduct education, healthy development, mentoring and other positive activities for youth;
- to combat crime within neighborhoods; and
- to prevent community deterioration.

Part III, Line 28

The Marietta Police Athletic League provided sponsorships to area youth for the Marietta Blue Eagles Youth Football. The 6th Grade Basketball Program was initiated, which allowed community youth to play league basketball - participants paid a nominal fee to defray costs of league fees, uniforms, equipment, tournament fees, etc. MPAL also paid for summer swimming lessons for area youth and youth were offered the opportunity to participate in the Marietta YELLS Mentoring Program, which combines mentorship with a focus on leadership development, academic achievement, community involvement and service. As in 2007, a number of community outreach and recreational activities were sponsored by MPAL, such as the Back to School Bash (providing free backpacks and school supplies to area youth), Holiday Around the World (providing holiday gifts to area youth), and RISE Teen Event. The tutoring program begun in 2007, with police officers donating their time, continued in 2008. All programs and activities continue to be designed to provide youth with positive experiences and role models, discouragement gang involvement and drug use.
