Reasons for Amendment

While preparing Whiteside Theatre Foundation's 2009 Form 990-EZ, especially while building a history of contributions received since inception to support Schedule A Part III calculations, several accounting errors came to light, prompting this second amended return. The major 2008 error was that the organization reported a donation of a Wurlitzer theater organ console from Benton County Historical Society valued at \$10,000. While they intend to donate it at some future time, Benton County Historical Society has clarified that title to the console has not yet passed and it should not yet be considered a donation. Overall, the difference in net assets between this return and the most recent amendment, filed in June 2009, is a negative \$8,837.
