28) STRONGHEART FELLOWSHIP

28 a) EXPENSES: \$32,645

Strongheart Fellowship is a healing and learning guidance program designed to help bright, resilient young people from extremely challenging circumstances around the globe – such as those rescued from child slavery, teenagers once abducted by rebel armies, young people orphaned by AIDS, and young survivors of extreme poverty and war. The program's purpose is to help these young people develop into compassionate, innovative problem-solvers and leaders that can affect significant social change.

• Completed Phase I of the Curriculum Development:

In 2008, Strongheart Group accomplished taking its Inaugural Fellow, Lovetta Conto, through completion of Phase I of the Strongheart Fellowship Program. Lovetta is a survivor of the Liberian Civil War and grew up with sporadic care and very little consistent education in a refugee camp. Lovetta Conto learned how to:

- let go of the limiting factors of her past war and refugee experiences
- take responsibility for her academic advancement
- be aware of her emotions and identify her feelings
- be flexible in her thinking
- communicate appropriately and effectively
- become financially self-sufficient so that she could move herself out of survival mode and have the ability to care about and help others
- become a spokesperson for the possibility of refugees changing their lives
- relate with other people with empathy and compassion
- raise awareness for the potential of all human beings to take bad situations and learn and grow from them
- inspire people to care deeper about the world around them

• Awareness Campaigns:

Strongheart is dedicated to helping each Strongheart Fellow master crucial real world skills to create their own "exit strategy from poverty" and address important needs within their communities and the larger world.

Strongheart successfully guided Lovetta Conto in learning skills she needed to be financially self-sufficient, enabling her to break away from the mentality that she was a victim in the world who needed aid to survive. This breakthrough caused her to move up Maslow's hierarchy of needs - past the physiological and safety needs stages - and into the stage where she could begin to think about and care for the community around her.

As part of her Strongheart Fellowship, Lovetta created a project that facilitated raising awareness for the issues that plagued her life – civil war and being a refugee. Lovetta created a piece of jewelry that she could use to help tell her story. Facilitated by Strongheart as part of her learning process, mentors tutored Lovetta in jewelry design and manufacturing. Lovetta designed a necklace from spent bullet casings collected in the jungle and off the streets of her country following its civil war. She turned the bullet casings into leaf-shaped jewelry to show that new life can arise out of the ashes of war. Lovetta conducted awareness campaigns to spread the message of the plight of refugees and how one needs to have hope in the face of darkness. An example of one of these awareness campaigns was the World Refugee Day Media Campaign which reached five media outlets and an estimated 7,000 people. As one article said, "Lovetta and her Akawelle jewels will make Controlarms.org proud because the symbolism couldn't be any stronger. When a metallic symbol and harbinger of death is squashed and shaped into a jeweled leaf, imprinted with the word "life," it speaks to the fragility, and at the same time, resilience and defiance of the human spirit."

• Invited Speaker at Prestigious Event:

Strongheart Fellow Lovetta Conto was a featured speaker at the Aspen Institute's Ideas Festival "Against All Odds: Profiles in Resiliency," where she spoke to over two hundred people from across the country and received a standing

ovation. She also participated in workshops with twelve of the country's top public high school juniors as part of the Bezos Scholars Program, a program of the Bezos Family Foundation.

• International Peace Prize:

Because of her work raising awareness for refugees, Lovetta Conto was chosen as a finalist for the 2008 International Children's Peace Prize - an initiative of the KidsRights Foundation with the support of the Nobel Peace Prize Laureates - presented by Archbishop Desmond Tutu.

29) TEN DAYS

29 a) EXPENSES: \$17,815

Ten Days is a hands-on, grassroots volunteer program that enables people from around the world to spend ten days on the ground in Africa as part of an organized service mission. The focus of the 2008 Ten Days volunteer program was to repair a war-torn building for the purpose of creating the facility for the Strongheart Fellowship Program and Community Center.

• Strongheart House and Community Center:

In 2008, after scouting locations around the world for the selection of the site for the first Strongheart House, Strongheart chose Liberia, West Africa not only because of its long standing history with America beginning in 1822 when the American Colonization Society was established to colonize Liberia as a place to send freed African-American slaves, but because it is a country with an incredible desire to overcome a long and brutal civil war.

Within Liberia, Strongheart chose a building in the small town of Robertsport in Grand Cape Mount County. This building, a 10,000 square foot structure, was once beautiful but had weathered fourteen years of civil war and twenty years total of no maintenance. The facility had been stripped by looters during the war and lost most everything.

Referring to this building as "Strongheart House" to convey a feeling of warmth and family, the facility's purpose was to be an international community home of exceptional young people from all around the world who are in the Strongheart Fellowship Program. In addition, it was to be the base of a community program offering learning opportunities to the local Liberian community.

Strongheart conducted a ten-person volunteer planning summit in 2008, at which the goals for Strongheart House were determined and the potential challenges and solutions were addressed. The summit resulted in the coordination of volunteer efforts for getting the house repaired so that it would be livable after its post-civil war devastation.

In 2008, Strongheart led a five-person volunteer team to Liberia to begin efforts to restore this facility that then became Strongheart House.

(At the time of this filing, this building is active as the Strongheart House and Community Center described herein.)

30) PLAN 180

30 a) EXPENSES: \$19,378

Plan 180 is a collaborative effort helping marginalized people in post-conflict regions access, understand, and utilize ideas and resources to improve their lives. The goal of Plan 180 is to bring into Robertsport "best practice" ideas, teachers, innovators, and thinkers from around the world to work directly with the citizens of Robertsport. The Strongheart team behind the Plan 180 initiative believes in the possibility of everyone - regardless of previous education level or lack of

literacy skills - to understand ideas that can dramatically improve their lives and the lives of their entire lineage as a result of their transformation.

• Planning and Partnership Recruitment:

Plan 180 was a collaborative initiative led by Strongheart for the purpose of consolidating resources from innovative thought-leaders and best-practice organizations to focus them on a single geographic area for the purpose of lifting that community out of post-conflict poverty and into global-class revitalization.

After deciding to make Grand Cape Mount County the location of the first Strongheart House, Strongheart made two trips to Liberia in 2008 to identify a wide-range of specific needs keeping the region stuck in post-conflict poverty. Meetings were held with local and regional government and civic leaders including the county superintendent, legislators, district commissioners, paramount chiefs, ministry coordinators, the capital city mayor, market women, youth program leaders, staff of the United Nations Mission in Liberia and the staff of the local schools, hospital and orphanage. Meetings were also held with the local citizens of the town where Strongheart House is located.

Robertsport is a small town with a population of around 4,000. Once flourishing fishing village, the town was devastated by years of civil war. Plan 180 is working on ways to help the citizens of Robertsport rise out of poverty and have a vision for a better life and a stake in the success of their society. It is Plan 180's hope that the work accomplished in Robertsport will be applicable to other communities throughout the developing world.

As part of the Plan 180 effort, Strongheart entered into collaboration with the non-profit organization FLOW. Co-founded by Whole Foods CEO John Mackey, FLOW is focused on the goals of sustainable peace and prosperity and is a sister organization to the Whole Planet Foundation which empowers the poor in global communities through microcredit. FLOW chose to partner with Strongheart to pilot its Accelerating Women Entrepreneurs program in Liberia, beginning with serving the market women in Robertsport, Grand Cape Mount County. In November 2008, Zoe Adams, Strongheart Executive Director, was a speaker at FLOW's Washington, D.C. "Peace through Commerce" conference hosted by George Washington University and the Institute for Corporate Responsibility. The conference's focus was on poverty alleviation through economic development and on increasing the adoption of ethical NGO and corporate practices that contribute to peace.

In addition, Strongheart team members, as part of the Plan 180 initiative, attended two key U.S. conferences of the National Association of Cape Mountainians in the Americas (NACA). NACA is the largest and most active organized group of Liberian ex-patriots in the United States. Strongheart presented at both of these conferences - the Annual Conference and the Reconstruction Conference. Strongheart also hosted a top delegate from Grand Cape Mount County, Liberia for a series of meetings with Plan 180 collaborators in the U.S.

In 2008, NACA awarded Strongheart with the "Distinguished Service Award" for its dedicated service aimed at improving the quality of life for the people of Grand Cape Mount County, Liberia.

31) NAME CAMPAIGN
31 a) EXPENSES: \$3,927

Northern Uganda was in a 22-year war which caused over one million Northern Ugandans to be displaced. In addition, in the five years before 2008 over 20,000 children were abducted in the dead of night from their homes and hiding places by a rebel group that called itself the Lord's Resistance Army (LRA). The conflict in Northern Uganda was Africa's longest-running war, exacting a terrible toll by targeting very precisely the children of the region. The Name Campaign was an effort to raise awareness of the plight of abducted children forced to be child soldiers and slaves.

• **Awareness Campaign:**

Inspired by the Museum of Tolerance's practice of giving visitors the name of an actual child affected by the Holocaust, the Name Campaign distributed "nameplate necklaces" that bore the name of an individual child abducted in Northern Uganda. The campaign's goals were to encourage Americans to see these children not as an overwhelming tragedy – but as individuals. In wearing the name necklaces, supporters pledged to remember that individual child – "to speak their name, tell their story, and bring them home." Over 6,000 necklaces were distributed and are worn by people as diverse as school children in California to senior citizens in Mississippi.

In 2008, the Name Campaign banded together with other non-profit organizations working to end the war in Northern Uganda through participating in a public statement regarding the failure of the LRA to sign the Final Peace Agreement. The statement also conveyed recommendations to the U.S. Government, the Government of Uganda and the international community regarding attacks on citizens and the release of women and children. In addition, it covered rebel leader mediation and the development of the "Peace, Recovery and Development Plan".

• **Care of Injured Formerly-Abducted Children:**

Children injured by the LRA received life-changing medical care through the Name Campaign. These children were brought to the Name Campaign's attention by the Rachel Rehabilitation Centre in Lira, Uganda, a program helping escaped child soldiers emotionally heal from the trauma of war, enter into school or receive vocational training, and reintegrate into their pre-war communities. Amongst these children were:

Rham Ibrahim - a sixteen year old boy who was abducted by the LRA and due to his abuse with the LRA suffered from a hip condition requiring hip replacement. The Name Campaign succeeded in obtaining donated surgery in the United States for Rham. He has now returned, fully healed, to Uganda.

Evaline Apoko – a young girl abducted by the LRA at the age of nine who suffered severe injuries to her face making it impossible for her to eat or speak. The Name Campaign succeeded in getting Evaline tens of thousands of dollars of donated facial reconstruction surgery in the United States and then returned her to Uganda. In 2008, the program continued to support Evaline's living and education in Uganda because she had been rejected by her family and village because of her deformities and the stigma of being a former child soldier. The program enrolled local Ugandan Victor Ochen in the oversight of Evaline's care.

31) NEXT RIGHT THING

31 a) EXPENSES: \$5,583

The Next Right Thing creates awareness of children from the developing world in desperate need of medical assistance with the intention of raising funds for medical travel costs or obtaining donated medical treatment. The program's goal is to connect children in medical need with people who can help. Depending on what's most appropriate, the Next Right Thing either assists with medical costs for in-country treatment or helps secure life-changing medical treatment free of charge in the United States. In the cases of children accepted for treatment in the U.S., Next Right Thing volunteers work tirelessly to raise funds for travel, obtain passports and visas and oversee travel logistics and host family arrangements.

• **Life-Changing Medical Care:**

In 2008, the Next Right Thing reviewed a dozen cases from East and West Africa brought to its attention by non-profits and individuals doing service work in these regions. A great amount of time was spent presenting cases to receive donated medical care in the United States or raising funds for medical services in the patient's country, if such services existed. When surgeries could be obtained and travel arrangements made (including visas, host families and volunteer travel

escorts) the Next Right Thing provided life-changing medical care to these children in need. Amongst the children served in 2008 were:

Lamine Traore - a six year old boy from the Ivory Coast who was born with rectal and urinary problems, including his intestine protruding from his abdomen. Lamine was living in constant pain and as a recluse not allowed to go to school or play with other children. The program made possible a series of intense surgeries and rehab in the United States. A Next Right Thing volunteer escorted Lamine to and from the United States. He is now at home in the Ivory Coast where he is living as a happy and healthy child with a bright future.

George Okello – a thirteen year old boy with an amputated leg as a result of a bomb injury was brought to the Next Right Thing's attention due to an increasingly swelling stomach suspected to be internal organ complications including possible kidney failure. Treatment was available and reliable in-country so the Next Right Thing sponsored George's medical services.

King David Onencan– a five year old boy who was a deep degree burn victim as a result of arson in his home. Coming from an extremely poor family, his medical condition went untreated and he suffered severe keloids over much of his body which, in addition to extreme deformity, caused sharp pain and intense itching. The Next Right Thing was able to obtain safe and effective in-country radiation therapy for King David.
