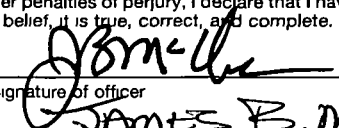

Part III, Statement of Program Service Accomplishments

Statement 1 - The purpose of the organization is to restore an historic estate significant to Atlanta's history for purposes of providing hospitality to the community and a nurturing, caring environment for families of patients who are undergoing care at Emory Hospital or Medical Center.
