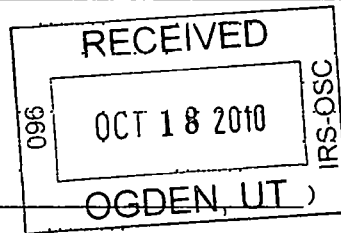

Amended Tax Return**NHT VIII, Inc.**

1. Had filed Form 990-N for 2007 and 2008.
2. Was formed as a non-profit tax exempt entity.
3. With a primary exempt purpose of promoting low-income affordable housing.
4. Appropriately filed with IRS for a Letter of Determination for its non-profit tax exempt status.
5. Acted as, conducted business as and complied as, with IRS and all other federal, state and local reporting agencies, as a non-profit tax exempt entity under 501(c)(3) /509(a)(2).
6. Endured a two year processing and review by IRS in determination of its tax exempt status.
7. Received its IRS Determination Letter as a 501(c)(3) tax exempt entity. IRS also determined the entity was a 509(a)(3) supporting organization.
8. The discrepancy between IRS' Letter of Determination as a 501(c)(3) / 509(a)(3) and the entity's conduct and compliance as a 501(c)(3) / 509(a)(2) was not initially noticed.
9. The discrepancy in classification was discovered during an IRS Examination of a related entity.
10. IRS, Tax Exempt Division, audited NHT IX, Inc. for the tax years ending in 2007 and 2008.
 - a. The examination of NHT IX, Inc. confirmed the determination the NHT IX, Inc. was a non-profit tax exempt entity und 501(c)(3) and a supporting organization under 509(a)(3).
 - b. The organization continues to qualify for exemption from Federal income tax.
 - c. The examination results were mutually agreed to by IRS and NHT IX, Inc.
 - i. NHT IX, Inc. had acted as and complied as a 501(c)(3) / 509(a)(2) entity.
 - ii. Had filed Form 990-N for tax years ending in 2007 and 2008 as an entity having less than \$25,000 in gross receipts.
 - iii. As a 509(a)(3) supporting organization, NHT IX, Inc. was not entitled to the gross receipts exception and filing of Form 990-N.
 - iv. NHT IX, Inc. was required to file Form 990 or Form 990-EZ.
 - d. NHT IX, Inc. properly filed a 990-EZ for tax years ending in 2007 and 2008 with the Revenue Agent during the exam and IRS accepted the return(s) as filed.
 - e. No penalties were proposed or accessed, as the exempt organization had shown good faith in trying to comply with all IRS laws and regulations.
11. IRS was made aware of and knew of numerous related entities that were the same type of entity, with the same structure and purpose as NHT IX, Inc.

12. IRS declined to expand the scope of the examination to include these related entities upon assurances from the main supported tax exempt organization that each entity would file the necessary return(s) to be in full compliance as a 501(c)(3 / 509(a)(3) supporting organization.

13. Richard W. Elder, Internal Revenue Agent, conducted the examination of NHT IX, Inc., he stated that for the compliance of the related entities we could:

- a. Use the examination of NHT IX, Inc. as a precedent.**
- b. That reasonable cause was found.**
- c. That penalties were not appropriate, that is was OK to use the examination of NHT IX, Inc. as basis for not applying penalties and interest.**

14. NHT VIII, Inc. respectfully requests the acceptance of the amended tax return(s), Form 990-EZ to fulfill its compliance requirements and that penalties and interest not be applied per the reasons specified above.
