The Friends of Johnson County Public Library is an organization consisting of local community volunteers who sell used books, weeded by the Library and donated by the public, four times annually. The money generated by the sales is donated to the Library and used by the Library to purchase prize incentives, hire entertainers and professional people for seminars and workshops, all of which are not able to be funded by public funds under Indiana laws.

Membership dues are minor - annually \$5.00 for individual and \$10 for families. Benefits to the members are few, allowing them to attend the opening night of the sales to purchase used books.

Most of the money generated by the book sales and membership dues is donated back to the Library.
