Scepter Publishers continued to provide unique, low-cost, or free publications educating various audiences including parents, young children, teenagers, and young adults in need of guidance and strong role models. Approximately 40,000 individuals were served through the distribution of over 139,000 books. These publications emphasize key areas of virtue and moral struggle including (1) to base one's life on service to others through work and ordinary activities, (2) promoting a positive view of the roles and importance of all persons, including the elderly, and the protection of all human life (3) the strengthening of family life as the primary way to improve the social, economic and moral life of U.S. society. Scepter's criterion for selection of its works comes from Christian teachings of charity and service to others and the community. Certain publications are based on the charisma and writings of Saints and teachings of the Catholic Church in order to develop and distribute books that teach a positive approach to deepen and develop virtue and habits that improve the life of the family and community. During 2008, Scepter continued these efforts through its release of a number of publications with an emphasis on positive behavior and the struggle towards personal excellence ("Virtuous Leadership"), effectiveness in marriage ("Covenanted Happiness, Love and Commitment in Marriage"), and improvement in ordinary life relationships ("From Resentment to Forgiveness"). It relaunched a book entitled "Time For God" which has proved highly popular. It emphasizes the importance of prayer and the power of religion as a force for good in a secular society. In this same vein, Scepter supported the book "Man and Values" which provides a framework for the development of a common moral outlook in society and a proper understanding of the natural law and its impact on societal behavior. Other Scepter titles on the subjects of prayer, religious practice, family advice and parenting, moral education, and Bible study continue to expand, with about 130 titles available. In addition, Scepter provides free booklets online on many of the same topics. Scepter also publishes biographies of persons exhibiting extraordinary virtue who also possess a high degree of religious faith. These in the past have included Charles Carroll, a signer of the Declaration of Independence who was instrumental in the establishment of religious freedom as a foundational principle. Another important figure is Thomas More, renowned as one of the greatest statesmen of all time, and whose spiritual and religious works Scepter has been publishing for 15 years. As an ongoing service to society, Scepter continues to provide free books to prisoners in the U.S. upon written request and asks for no compensation. It does this because research has shown that although the average recidivism rate for prisoners is 70%, those who make a religious conversion in prison and seek help to maintain it have an extremely low likelihood of returning to crime upon their release. These prisoners request any number or type of books from Scepter, whether Bibles, Bible study commentaries, prayer books, or books explaining religion and encouraging the practice of prayer and virtue. From time to time Scepter will also make donations of prayer books and Bibles to worthy not-for-profits. Finally, Scepter's publication of the short book "Virtuous Leadership" has led to other translations being planned to provide inspiration from the lives of persons who were not necessarily celebrities but whose lives were marked by service rather than ambition and the desire for wealth or power. The aim, along with all of Scepter's publications, is to encourage personal improvement and educate its readers on how to improve one's life and other's lives through service and charity to others applied in one's ordinary situation, informed by one's religion and the positive habits and behavior of living one's faith in and through normal responsibilities and work.
