**Revenue Procedure 2014-11**  
**Retroactive Reinstatement**

**REASONABLE CAUSE STATEMENT**


The Fast Club of Oshkosh, Inc. requests that its tax exempt status which was automatically revoked be reinstated retroactive to the date of revocation.

The reasons for the request are that the organization, being newly incorporated, had officers who were unfamiliar with the procedures for filing exempt organization returns. The mailings to the officers of the corporation were made to officers at their home addresses and following a change in officers, mailings did not reach new officers. Therefore, the corporation did not timely file its returns. All of the returns for the organization have been filed herewith. The organization has taken steps to ensure that this will not occur again by obtaining a post office box to receive all mail. The organization has also had more continuity in officers and will ensure that future officers take steps to train incoming officers regarding the filing of tax returns.

The organization has filed all of the annual returns for all taxable years from the date of organization to date.
