Rural AIDS Action Network (RAAN) provides services to the Persons Living With or Affected by HIV/AIDS (PLWHA) in 2008, RAAN served 206 PLWHA. Of those served, 55 were new to the agency. Some of the major services follow:

- RAAN's partner clinics and Infectious Disease Specialists provided primary medical care to 142 PLWHA who made 430 visits for medical care
- RAAN staff and partner agencies conducted 374 free HIV tests. Each participant received a personal risk assessment and prevention education session.
- RAAN Medical Case Managers served 160 clients through 3,277 visits or contacts.
- RAAN helped 70 clients access medical services and adhere to treatment regimens by paying for doctor visits and prescription medications.
- Twenty-two PLWHA attended at least one meeting of RAAN's support groups in Mankato and St. Cloud.
- Transportation assistance was provided to 154 PLWHA, helping clients access medical and other services
