

SOME OF THE RECEIPTS AND DISBURSEMENTS MAY BE FROM FUNDRAISING ACTIVITIES AND RELATED EXPENSES BUT THE RECORDS DO NOT PERMIT AN ACCURATE ALLOCATION. IT APPEARS THAT ALL RECEIPTS WERE SMALL AMOUNTS AND ALL EXPENDITURES WERE ENTIRELY FOR THE PROGRAMS OF THE ALGONA COMMUNITY SCHOOL DISTRICT. A NEW TREASURER AND NEW RECORD-KEEPING PROGRAM IN 2009 PERMIT ACCURATE DETAILED REPORTING ON THAT RETURN AND THEREAFTER.
