**EXPLANATION OF LATE FILED RETURNS:**

Forms 990-EZ of the Waverly Public Library Foundation for calendar years 2006, 2007 and 2008 are filed together with this year's return (2009). Prior to 2006 there was no requirement for this organization to file any type of return as a tax exempt entity. With the change in the law the Waverly Public Library Foundation struggled to find someone to assist them in complying with the new filing requirements. Until recently, the City Attorney for the City of Waverly had expressed his willingness to tackle the Form 990-EZ and Schedule A, but never returned a work product. This tax filing season a new preparer was found who agreed to prepare all four years' returns. None of the individuals involved, including the preparer, have had any experience with the forms required to be filed. These Forms 990-EZ are prepared and filed believing them to be accurate and complete.

As you can see the donations and expenditures of the Waverly Public Library Foundation are modest. No one in the organization is paid any compensation directly or indirectly. No donor controls how the funds donated are spent. This organization supports the Waverly Public Library in providing special landscaping and recently providing funds for archiving local newspapers. The largest single project has been a foot bridge between the library grounds and a child care center next door.

From this point forward a Form 990-EZ and any support schedules will be filed on a timely basis. If there is any feedback from the returns filed herewith, please do not hesitate to point out any errors or omissions. They will be promptly corrected.
