

There has been a notification of a change in the character and method of operation of Catch the Fire Ministries, Inc.

("CTF"), as required by the letter dated October 22, 2002 granting CTF exemption from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("the Code") as an organization described in Section 501(c)(3) of the Code ("the Determination Letter").

CTF was established in Raleigh, North Carolina as a not-for-profit corporation on March 7, 2002. As noted above, CTF applied for and received its Determination Letter, which is dated October 22, 2002.

CTF continued its initial activities - recording and disseminating TACF services - until 2005. At that time, due to a lack of support, CTF became dormant and remained so through 2008, but was never formally dissolved or liquidated.

In September 2008, the decision was made to undertake a TACF-affiliated church plant in Raleigh. One of the principals involved in that process, Joseph Call, was the founder of CTF and offered to allow the new church to operate through the dormant, though still existing, CTF organisation. This offer was accepted and CTF began functioning as a church called "CTF Raleigh".

A letter was submitted and received by the IRS to keep the non-profit status and change the status to a church.
