



Cetaceans campaign: EIA's Cetaceans campaign is focused on curbing the commercial trade of cetacean (whale, dolphin and porpoise) products in Japan and on instigating an end to Japan's mass cetacean hunts. As a result, thousands of stores in Japan as well as Japan's three historically largest manufacturers of whale meat have ceased involvement in the whale meat trade.

Forest campaign: The Environmental Investigation Agency's (EIA) Forest campaign is protecting the world's remaining forests, and the wildlife and people dependent on them by stopping illegal logging, advocating sound forest governance, and campaigning for high-level policy solutions to curb demand for illegally sourced timber and derivative products. EIA's ability to track illegal timber through complex international trade routes gives us the tools necessary to tracking the global illegal logging crisis at all levels.


