


Statement 3 - Explanation for Not Filing on Time**Description**

Greystone Outreach Legacy Foundation was organized in December 1999 and was essentially inactive until 2007, at which time the organization initiated the current "Fallen Heroes" event to provide financial and other assistance to organizations devoted to addressing charitable, educational and benevolent purposes with an emphasis on soldiers and their families. As with any organization, of this type, much reliance is placed on the sacrifice of individuals through donation of their services. With the period of inactivity and a continuing change of active board members the filing of returns was inadvertently overlooked and all involved assumed that, due to the small amount of revenues, a filing exception was met. Only upon hearing that all 501(c)(3) organizations would lose their exempt status, if proper report filings were not made by October 15th, was the matter looked into and the organization discovered that it had not properly filed the required returns. The organization had no intent to circumvent, avoid or ignore filing timely returns and has since taken steps to assure timely filing with the retention of a certified public accountant. With consideration of the benevolent nature, for which this organization was formed, and the financial hardship which would be incurred, please consider this return as timely filed and abate any proposed penalties.
