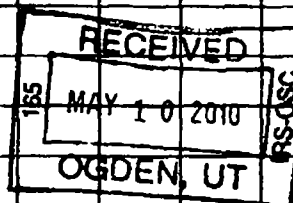

FORM 990-EZ FOR 2008 IS UNCHANGED. HOWEVER, SCHEDULE A IS AMENDED AND SUBMITTED HEREWITH. WE HAD ONE DONOR WHOSE ACCUMULATED DONATIONS REACHED \$5000 IN 2008 AND HE BECAME DISQUALIFIED. RATHER THAN INCLUDING HIS \$1000 DONATION FOR 2008, I MISTAKENLY INCLUDED ALL HIS DONATIONS FROM PRIOR YEARS, WHICH OVERSTATED THE AMOUNT RECEIVED FROM DISQUALIFIED INDIVIDUALS. ALSO, I FORGOT TO INCLUDE A SMALL LOSS WE INCURRED FROM AN ACTIVITY RELATED TO OUR TAX-EXEMPT PURPOSE, SPECIFICALLY A CONFERENCE. SEE LINE 7A, COLUMN E AND LINE 2, COLUMN E FOR THESE MINOR CHANGES.
