The Bicycle Recycling Program (BRP), run entirely by volunteers, procures donated or abandoned bikes and restores them to safe and reliable working order. It is a cooperative venture with local social support agencies who distribute the reconditioned bikes to individuals in the Athens community who are underserved by private and public transportation. Camp Summer Spree, a project of BRP, is a week-long day camp experience that teaches bike repair to Athens' preteens.

The Safe Routes to School (SR2S) program is a joint effort between the Clarke County School District and BikeAthens. The primary goal of this program is to promote physical activity among school-age children while making our streets safer for those who cannot or do not drive. This initiative, called Safe Routes Athens, started modestly but enthusiastically in 2005 at Barrow Elementary. In order to promote its expansion to all Clarke County public schools over the coming years, BikeAthens has led the grant writing efforts to fund this program through the School District.

The Bicycle Education Program provides cyclists the skills and confidence they need to ride safely and legally in traffic or on trails. Coordinated through the League of American Bicycling, the BikeAthens organization has trained and certified League Cycling Instructors set up to provide basic cycling safety courses, called Road 1 and Kids 1, to local individuals. The program also includes practice rides (Courteous Mass) a monthly, casually-paced bike ride of 5-6 miles around town is held on the last Friday of the month.
