Each year the Board of Directors, through its Scholarship Committee, designates a small contribution to be made to one of Louisiana's public universities. Based on a lottery type system, the committee determines which school is to receive the contribution. The Scholarship Committee does not designate the student(s) to receive the award, as that determination is made by the university itself. The committee's only request is that it be awarded to a student(s) of high moral character and true financial need.

The following contributions were made during the periods of 2007 - 2010.

^{**} In 2010 the contribution of \$4,050 was equally divided between the three (3) designated schools with each receiving \$1,350.
