REMOVAL OF CO-TRUSTEE AND APPOINTMENT OF SUCCESSOR TRUSTEES FOR THE TRUST AGREEMENT AND DECLARATION OF TRUST OF THE KEITH AND MATTIE STEVENSON FOUNDATION

The parties to this instrument are KEITH T. STEVENSON, as Grantor (the "Grantor"), and KEITH T. STEVENSON, MATTIE F. STEVENSON and KANALY TRUST COMPANY, as Co-Trustees (the "Trustees").

RECITALS:

The following facts form the basis for this agreement:

- 1. The Grantor and the Co-Trustees, as trustees, entered into a trust agreement on April 3, 1992 (the "Agreement), which established THE KEITH AND MATTIE STEVENSON FOUNDATION (the "Trust");
- 2. The Co-Trustees have continuously served as Co-Trustees of the Trust since the inception of the Trust;
- 3. Section 2.5 of the Agreement provides that the Grantor may remove any Trustee, with or without cause, upon giving thirty days written notice to the then-serving Trustee (unless waived);
- 4. The Grantor desires to exercise his right to remove KANALY TRUST COMPANY as a Co-Trustee of the Trust, leaving the Grantor and MATTIE F. STEVENSON, as the remaining Co-Trustees of the Trust; and
- 5. Pursuant to the authority granted in Section 2.6 of the Agreement, the Grantor desires to appoint successor trustees of the Trust in the event that both he and MATTIE F. STEVENSON are unable or unwilling to serve. Under such circumstances, the Grantor appoints DAVID M. DOLL and DIANA C. M. KREMERS to serve as Co-Trustees of the Trust (or in the event that one of them fails or ceases to serve as Co-Trustee, the remaining shall continue to serve as the sole Trustee).

AGREEMENT:

The parties hereto agree as follows:

- 1. That effective as of the date hereof, by execution below, and for the reasons, representations, agreements, and inducernents contained herein, the Grantor hereby removes KANALY TRUST COMPANY as a Co-Trustee of the Trust;
- 2. KANALY TRUST COMPANY hereby acknowledges its removal as a Co-Trustee, and hereby waives the thirty day notice requirement required by Section 2.5:
- 3. Effective as of the date hereof, the Grantor and MATTIE F. STEVENSON are the remaining Co-Trustees of the Trust; and
- 4. Pursuant to Section 2.6 of the Trust Agreement, the Grantor hereby appoints the individuals named above in Section 5 as successor trustees, to serve in the order provided in Section 5 in the event that the Co-Trustees fail or cease to serve as Co-Trustees of the Trust.
