We do not believe, under the rules of the IRS, that we are required to complete a tax form. However, some of our contributors require a copy of our 990ez. So, starting in 2007 we started filing on an annual basis.

The mission statement for Payson Helping Payson is to provide assistance to those individuals and families who find their lives in a "State of crisis" or in an emergency situation critical to personal health and or safety.

This charity was started to address the problems of low income or fixed income families in making rent or utility payments.

Payson Helping Payson (PHP) is funded by local churches, businesses, individuals and service organizations, and we hope to be in a position to help needy families in crisis when other public funds are not available.

PHP is a 501©3 non-profit organization composed of about 15 board members. The board meets every quarter to ensure that PHP continues to be administered according to our charter.

PHP receives approximately \$10,000 to \$15,000 a year in donations. 100% of those funds are distributed to families in crisis. We have no expenses other than stamps and stationary.

PHP does not have an office or any employees. The case managers work from their own homes. This is 100% volunteer work.
