The Utah Pride Center is Utah's leading organization for the advancement of Gay, Lesbian, Bisexual and Transgender (GLBT) visibility, education and empowerment. It serves as "The catalyst for personal growth, acceptance and equality for GLBT people in Utah", a safe and affirming sanctuary for GLBT people, provides programs and services that empower, educate and entertain the GLBT community, and strengthens the physical, social, emotional and spiritual well-being of GLBT people.

In addition to being the central clearing house for GLBT community members and friends, the Center has an expansive outreach and education program that serves to educate through formal training, films, discussions, social gatherings and community-wide events. This arm includes cultural competency education designed specifically for Utah social services agencies, schools and health care facilities. It also includes expansive efforts to educate those who work to support out of home youth. The Center and our volunteer army are responsible for Utah's second largest festival - the Utah Pride Festival - which attracts over 20,000 participants. Much of our outreach and education work is supported by volunteers committed to human rights and better understanding within the GLBT community and beyond.

4b (Code) (Expenses \$ 156,775 including grants of \$ 0) (Revenue \$ 32,383)

The Center offers meeting spaces to community organizations, a full calendar of programs and services the celebrate, educate and support GLBT people living throughout the Salt Lake metro area and greater Utah. The staff and dedicated volunteers have a wide array of professional resources at their disposal to address concerns that adults may have as they enter the "coming out" process and as they live as openly GLBT identified people in Utah. A major program focus is Health and Wellness, which focuses on healthy life choices by GLBT individuals, breast cancer awareness and HIV/Aids prevention/education.

4c (Code) (Expenses \$ 121,935 including grants of \$ 0) (Revenue \$ 15,150)

The challenges that face today's youth differ in many ways from those faced by our youth 10 or 20 years ago. We operate Utah's only stand-alone GLBT Youth Activity Center and over the years it has become the "go-to" resource for the Utah community as they work to understand and support GLBT youth and their families. The "TINT" offers numerous social activities and support groups including a transgender youth group, a parents of transgender youth support group, COLAGE and a Queers in Action leadership group. Every offering integrates HIV/Aids prevention and education for our GLBT youth and their allies. In addition, the Youth Activity Center produces Utah's only Queer Prom for GLBT and allied youth ages 14-20.
