Girls RAP (Rights! Action! Power!), a youth development program for 10-14 year old girls, serves over 150 participants each year in five Seattle public middle schools. Girls at Denny, Hamilton, and Washington Middle Schools participate in after-school groups and one-on-one mentoring. Girls at Aki Kurose and Meany Middle School participate in weekly girls' health class and ongoing one-on-one referral support. Outside of school, girls from all five schools are also invited to participate in a four-week intensive leadership and educational day camp during the summer. Girl RAP encourages girls to cross the social divides in their schools. Girls of different ethnicities, cultures, socio-economic backgrounds, ages and interests come together to form relationships marked by respect and collaboration.

STAGES (Strength Through All-Girl Education and Support), offers several intervention and prevention programs for girls in or at great risk of entering the juvenile justice system. Girls participate in health and wellness workshops three times per week, year-round, in King County Juvenile Detention. Outside detention we offer advocacy/case management services focusing on violence prevention and academic achievement. At Sartori Education Center (Renton School District alternative school) and Alder Interagency School (Seattle public school district) we provide health and wellness groups, foster access to resources and participate in community service projects. Lastly, STAGES offers an intensive seven-week summer youth employment program. Each participant receives academic credit and may earn a stipend of up to \$900.
