THE ORGANIZATION PROVIDES OPPORTUNITIES FOR VERY LOW, LOW AND MODERATE INCOME RESIDENTS OF SAN JUAN COUNTY TO PURCHASE AFFORDABLE HOUSING. THIS IS ACCOMPLISHED THROUGH ADMINISTRATION OF HOME BUYER PROGRAMS, DEVELOPMENT OF NEW AFFORDABLE HOUSING, ACQUISITION AND/OR REHABILITATION OF HOME BUYER PROPERTIES AND DOWN PAYMENT ASSISTANCE. GOVERNED BY A VOLUNTEER BOARD OF DIRECTORS. HOMES FOR ISLANDERS SUPERVISES THIS PROCESS.
