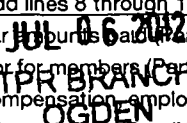
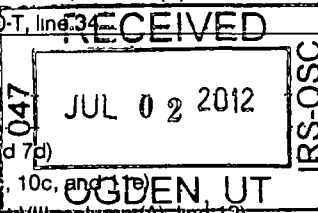

Housing and Eviction Defense: Advocates prepared tenants being unfairly evicted to represent themselves in court and provided legal representation to help clients retain their residency or get relocation benefits and move to better quarters. Advocates also focused on improving the conditions of housing for low-income people by pursuing litigation to get substandard buildings repaired and collaborating with city and state efforts to rehabilitate slum housing, improve code enforcement, and increase the availability of low-cost housing. This program served 7,743 clients in 260 days.
