YMCA-Camping-Day and residential. The YMCA camping program provides a lasting experience of personal enrichment. Residential and day camps offer adventure and learning activities that provide challenge and promote spiritual awareness, mental development, physical well-being, social growth, and self-respect. Camping helps youth become aware of their physical and mental capabilities, to recognize the value of cooperation, and to gain confidence. Helps youth appreciate diversity, respect people of different ages, abilities, incomes, races, religions, cultures, and beliefs. All programs are infused with the YMCA's core values of caring, honesty, responsibility and respect. Over \$8,000 of scholarship aid was offered to make sure no one was turned away because of inability to pay.

YMCA-Childcare and preschool: Our YMCA provides high quality childcare by providing comprehensive activities for preschool and school age children drawing on diverse members of the community. We provide both full and part time options to serve a wide range of family scheduling needs. Woven into the fabric of the YMCA mission is a commitment to strengthening families, using the core values of caring, honesty, respect and responsibility. YMCA childcare programs relieve the burden of balancing work and family and make it possible for parents of children in our care to remain gainfully employed, knowing that their children are thriving in a safe, developmentally sound environment. The YMCA provides tuition assistance for childcare services. Over \$115,900 was awarded to families to defray their fees this year. In addition, we provide aid to the families who need help due to family violence, substance abuse, etc. by collaborating with other social service agencies. We provide a variety of activities that emphasize parent education and help parents learn more about how to raise healthy, happy children who develop self-esteem and moral and ethical values.

YMCA-Health Enhancement: Helping people of all ages and abilities develop in spirit, mind and body is at the core of the YMCA movement. Our programs are designed to help people create realistic goals for self improvement and emphasize disease prevention through regular exercise, proper nutrition, stress management, and health education. Sports programs for youth, families and adults promote teamwork, interaction, and development of social and physical skills. Each individual, couple or family who seeks a healthy lifestyle is provided an opportunity to fulfill that goal with guidance and council from trained staff and volunteers who tailor each program to the individuals need. Over \$20,600 was offered in scholarship aid to make sure no one was turned away for an inability to pay.
