IN THE YEAR ENDED MARCH 31, 2009 MHT HOUSING ACQUIRED AND REHABILITATED 784 APARTMENTS FOR PRESERVATION IN THE LOW INCOME HOUSING SYSTEM. MHT HOUSING CLOSED ON THREE ADDITIONAL PROJECTS WHICH WILL PROVIDE AN ADDITIONAL 457 UNITS FOR PRESERVATION IN THE LOW INCOME HOUSING SYSTEM. THESE PROJECTS WILL UNDERGO MAJOR RENOVATIONS AND WILL HOUSE APPROXIMATELY 1,500 LOW INCOME INDIVIDUALS.
