Wood River Land Trust Program Achievements

Land Acquisition/Protection:

3/1/2009 – 3/31/2009:

Purchase at bargain sale of 100 acres along Porcupine Creek in the Pioneer Mountains for a permanent preserve; riparian areas, wildlife habitat, access to public lands.

River Health and Restoration:

Staff continues planning (organizing engineering, designing, mapping, surveys, permitting) for Phase II of the Croy Creek Wetland project which, if approved by local agencies, will include a boardwalk with an educational component.

Land Stewardship:

In March, staff worked on preserve management plans and other stewardship files. (Snow hinders stewardship visits to most properties.)
