Consists mainly of hospitalization medical costs and professional medical services amounting to \$159,135. The objectives of these funds is to promote and provide medical treatment of reconstructive surgery and cancer. The medical costs coverage include: anesthesiology, surgery, dental surgery, studies, supplies, audiology, and medication. During the year, an average of \$1,908 children were served with these funds and 490 remained as active patients. In the case of the professional medical services is for the educational program. This program provides patients with the required educational credits to complete grades during the hospitalization period. The program had 31 beneficiaries during 2008 and 43 during the year 2009.

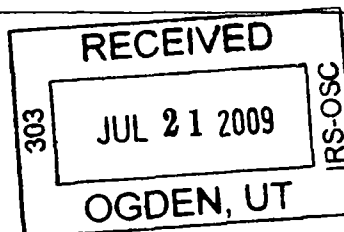
