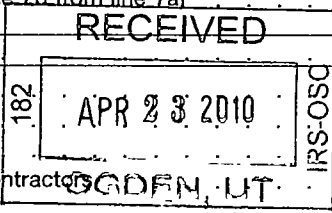

Sci-Tech Discovery Center began nearly 10 years ago as a project of the Junior League of Plano. Years of study, including extensive research and consultant reports, verified the viability of this project. The project took on an additional credibility with the establishment of its own 501(c)3 status in March 2004 and a Board of Directors to direct the activities of the organization.

Sci-Tech Discovery Center organized and held two summer exhibits to prove that the concept of a science and technology museum in Collin County is viable. Approximately 14,000 individuals visited each exhibit, helping establish the viability of such a project.

Since 2005, Sci-Tech has continued to produce, sponsor and participate in regular outreach programming designed to fulfill its core mission of delivering hands-on, exciting learning experiences focused on math, science and technology, while continuing to build public support for its long-term goal of establishing and building a permanent science and technology discovery center. These activities have included hosting summer workshops, camps and events at local youth centers and libraries. In May 2009, Sci-Tech began discussions with the City of Frisco to open a permanent center in a city-owned building and a contract was negotiated with Advanced Animations to rent an exhibit to open in Frisco in October, 2009.
