The Cincinnati Woman's Club (the Club) mission and purpose is to create an organized center of thought and action among women for the promotion of charitable, educational, literary, social and artistic growth, and whatever relates to the best interest of the city. The Club accomplishes its mission through three main programs: Scholarship, Philanthropy and Education.

 The Education program enriches Club members culturally, socially and artistically. The Education Program held a number of programs throughout the year designed to culturally and artistically enrich its members. Programs and meetings were presented on the following topics during 2008, Art, Civics, Music, Antiques, Arts and Crafts, Biblical Literature, Book Discussions, Choral, Writing, Language, Finance, Garden, Gourmet, Physical Fitness and Photography.

The Philanthropy program provides assistance to various charities selected by Club members throughout Cincinnati. During 2008, the Club provided support to American troops in Iraq through its "Project Care Package" program. The club was able to provide support to approximately 330 military units. In addition, the Club donated to various Cincinnati Organizations throughout 2008. In addition to the monetary donations provided, the Club contributed a number of service hours and non-monetary donations to various organizations throughout Cincinnati. Service hours consisted of performing administrative duties, tutoring students, driving disabled individuals to appointments, and various tasks for the Organizations served by the Club. Non-monetary donations include eyeglasses (approximately 150, which were subsequently distributed to the needy around the world), Socks and Mittens (approximately 300 pairs of socks and mittens were collected for distribution by the Salvation Army), bedding supplies, arts and crafts items, and food items. Non-monetary donations were provided to various organizations throughout Cincinnati.
