The ADAF, a 501(c)3 charity, serves as the philanthropic arm of the American Dietetic Association and is the world's largest charitable organization devoted exclusively to nutrition and dietetics. Focusing on four key initiatives -- scholarships, awards, public education related to healthy weight for kids and food and nutrition research the ADAF is dedicated to funding the future of the dietetics profession through research and education. ScholarshipsAs the largest provider of dietetics scholarships, the ADA Foundation provides funding to deserving students at all levels of study. ADAF awarded \$255,000 to 226 dietetics students who headed back to school this fall. AwardsADAF provides education stipends, recognition and leadership awards to Registered Dietitians and Dietetic Technicians, Registered. More than \$75,000 is available each year. ResearchThe ADA Foundation understands the value of research conducted by Registered Dietitians. To support research in the dietetics profession, ADAF established the ADAF Food and Nutrition Research Endowment which funds member-conducted research on top issues identified by ADA and ADAF. In addition to the research endowment, ADAF has several named funds which support various areas of research. ADAF also funds the research efforts of the ADA's Research and Strategic Development Department including projects through the Dietetics Practice Based Research Network and Evidence Analysis Library. Each year, up to \$150,000 is available through ADAF's research funding. Healthy Weight for KidsThe ADA Foundation continues to promote a healthy weight for kids and their families by supporting initiatives that make available the knowledge and expertise of the Registered Dietitian and ADA member in helping to address the issue of childhood obesity in this country. The ADA Foundation's vision is to be a leader in promoting healthy weight in families and children. Healthy Schools PartnershipThe Healthy Schools Partnership is a partnership between ADAF, the American Council for Fitness and Nutrition and PE4life, an organization advocating quality, daily physical education programs for all children. The Healthy Schools Partnership promotes nutrition and physical education in schools by training and supporting RD-nutrition coaches to deliver nutrition education alongside PE teachers. The program currently includes schools in Kansas City and Iowa with plans to expand the program in Washington, D C and Chicago, Illinois in 2010. Champions for Healthy Kids Since 2002, ADAF has partnered with the General Mills Foundation to annually award 50 grants of \$10,000 each to nonprofit, community organizations across the U S. Funded programs educate youth about fitness and nutrition in innovative and behavior-sustaining ways while providing opportunities for RDs and DTRs to work with non-profit organizations.
