



SCH I - Faculty teaching fellowship	PART I, ITEM 2	The American Association of Orthodontics Full-time Faculty Teaching (FFT) Fellowship Program was provisionally approved in May 2007 by the House of Delegates. The orthodontic education faculty shortage is an AAO critical issue, and in response the leadership has focused on key strategies to eliminate the faculty shortage by reducing the student debt for dental education. Purpose and objectives of the Fellowship include: Increase the pool of orthodontic educators; Provide Fellowship funds to reduce debt by covering orthodontic program tuition and/or living expenses in an effort to stimulate interest in orthodontic education careers among current students, residents and junior faculty; Evaluation of the effectiveness of the Fellowship program will be measured and assessed by data collection that will include: 1) number of Fellows, 2) number of new orthodontic faculty members generated as a result of the Fellowship, and 3) number of Fellows who complete a minimum of two years of orthodontic teaching. TERMS: The Fellowship Program is open to a minimum of six orthodontic junior faculty members, defined as those with five or fewer years post completion of the orthodontic program, and/or students and residents attending U.S. and Canadian accredited orthodontic graduate programs. Upon application, Fellowship candidates must designate their number of years of Fellowship participation with a minimum of two and a maximum of five years. For each year of Fellowship program participation, the recipient will agree to teach orthodontics for a corresponding number of years at an American Dental Association (ADA) accredited orthodontic graduate program. Recipients may receive up to five years of Fellowship support at an average of \$30,000 per year. For example: the Fellowship award is based on the number of years at \$30,000 each and not to exceed years or \$150,000 e.g., 3 years x \$30,000 = \$90,000 total funding. Fellowship funds will be distributed in equal or unequal annual payments to fit the needs of the individual recipient for a period of up to five years as determined at the time of the Fellowship application. ELIGIBILITY: Fellowships/Awards are intended for those individuals who are preparing for, or beginning a career in orthodontic education in the U.S. and Canada, i.e., students or junior faculty, respectively. Candidates must meet the following eligibility requirements for consideration: U.S. and Canadian citizens; Foreign nationals who possess a U.S. "green card" or its Canadian equivalent. Those foreign nationals not yet in possession of U.S. "green card" or its Canadian equivalent, as long as the candidate and the institution will stipulate that obtaining such status is the candidate's intention and where there is demonstrable evidence of this intent. Student, resident and/or junior faculty in good standing at a U.S. or Canadian ADA-accredited orthodontic graduate program. Good academic standing as verified by submission of an orthodontic program transcript and a minimum of three letters of recommendation, Member of the American Association of Orthodontists (AAO). Submission of all application materials, including letters of support, by published deadlines. Participation in the following Fellowship activities: Meet at least monthly with the department chair or a designee to discuss Fellowship goals, plan for activities and progress assessment; Conduct an educational research practicum, or other type of research, during the Fellowship in conjunction with their department chair or a designee (see Addendum B); Serve as an instructor for orthodontic teaching practicum's in educational settings: classroom, small group conference, preclinical laboratory course and orthodontic program clinic; Complete an annual Fellowship evaluation/survey; Participate in the annual Fellowship interview; Participate in a telephone focus group to provide in-depth program assessment and recommendations to allow the program evaluator to follow-up on issues identified in the evaluation, as needed. Further, if the Fellow candidate is not pursuing a formalized degree in education, he must agree to complete a minimum of four courses of instruction from the following six educational areas, or other proposed courses as approved by the Steering Committee: 1) Educational philosophy and psychology, 2) Curriculum development, 3) Theory of learning and educational measurements, 4) Research design, methodology and statistics, 5) Computer science and technology in education and 6) Scientific communication skills and scientific writing. Agree to begin fulfilling full-time orthodontics teaching commitment within three months of graduation. Submission of an annual report detailing courses taught, lectures, publications, mentoring activities, etc. for each required teaching year following the Fellowship. INSTITUTIONAL REQUIREMENTS: The appropriate authorized individual (Dean, Program Director, Department Chair, etc.) at the candidate's program submits a letter of support to the chair of the FFT Fellowship Program Selection Committee which includes the following: Commitment to provide institutional resources needed by the Fellow candidate to complete the outlined FFT Fellowship Program duties to include: Conduct monthly meetings with the Fellow; Participate in the annual telephone interview; Complete the annual evaluation / survey; Provide advice regarding the teaching and research practicum. Further, if the Fellow candidate is not pursuing a formalized degree in education, the institution must agree to provide, and the Fellow must agree to complete a minimum of four courses of instruction from the following six educational areas, or other proposed courses as approved by the Steering Committee: 1) Educational philosophy and psychology, 2) Curriculum development, 3) Theory of learning and educational measurements, 4) Research design, methodology and statistics, 5) Computer science and technology in education and 6) Scientific communication skills and scientific writing.
