The school provided inter-scholastic athletic programs to its middle and upper school students in six sports, with the goal of promoting both positive lifelong physical activity habits, as well as the character development that is fostered by competition.

The school provided a Hot Lunch Program (in compliance with the National School Lunch Program (NLSP)) for its students and faculty, designed to offer nutritionally adequate, appealing and affordable meals, with the goal of enhancing the educational experience through excellent nourishment and promotion of positive lifelong eating habits.
