**1. Nature of Activities and Significant Accounting Policies**

Nature of Activities

Ruby Tuesday Team Disaster Response Fund (a nonprofit organization) was established by officers of Ruby Tuesday, Inc. for the purpose of providing assistance to Ruby Tuesday Team members (company employees and their families) who are adversely affected by disaster situations (man-made or natural) that may occur in the future.

Basis of Accounting

The accompanying financial statements have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under this method, revenues and their related assets are recorded when received rather than when earned. Expenses and their related liabilities are recorded when paid rather than when incurred.

Income Taxes

The Organization is a not-for-profit organization that is exempt from income taxes under Section 501 (c) (3) of the Internal Revenue Code.

Contributions Received

The Organization reports gifts of cash and other assets as restricted revenues if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of revenues and expenses – cash basis. The Organization does not accept contributions earmarked for specific individuals. For the year ended May 31, 2009, there were no restricted revenues.

**1. Nature of Activities and Significant Accounting Policies (continued)**

Related Parties

Officers of Ruby Tuesday Team Disaster Response Fund are also officers of Ruby Tuesday, Inc. that provides the facilities for the organization to hold meetings and to use equipment such as copiers, computers, printers and phones. Ruby Tuesday, Inc. also provides all office supplies to the organization at no cost. All contributions to the Fund are from Ruby Tuesday, Inc. or a Ruby Tuesday, Inc. employee, a franchise or franchise employee.

Estimates

The preparation of financial statements in conformity with the cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**2. Concentrations of Risk**

At various times during the fiscal year, Ruby Tuesday Team Disaster Response Fund cash in bank exceeds federally insured limits. At May 31, 2009, the Fund's uninsured cash balances totaled \$34,980.
