Youth Development - YMCA Youth Development concentrates on nurturing the potential of every child and teen This is accomplished through providing quality programs for child care, day camp, classes in the arts (dance and art), classes in sports for children and teens, as well as swim teams and a teen basketball tournament Many of the youth programs are offered free to members Financial assistance for these programs, other than child care and day camp, equaled \$19,297 and assisted 112 individuals YMCA Child Care works to help children develop to their fullest potential, support and strengthen the family unit, teach, model, celebrate, practice, praise, and reinforce the four character values of caring, honesty, respect and responsibility, foster health and well-being for children and families, deepen a commitment to service and motivation to learn, foster the leadership potential and civic engagement of young people, and champion inclusion In order to minimize the financial barrier to attend, \$91,861 was given in financial assistance to the families of 80 children YMCA Day Camp has a goal to help children growing physically, mentally, and spiritually while using a natural camp site The program objectives are grow personally, clarify values, develop specific skills, improve personal and family relationships, become better leaders and supporters, appreciate diversity, and have fun The YMCA works to remove the financial barrier of attending camp for all children Financial assistance was provided for 212 children and totaled \$69,225
