What is the organization's primary exempt purpose? A SAFE PLACE, FOUNDED IN 1978, HAS A MISSION TO BREAK THE CYCLE OF DOMESTIC ABUSE BY PROVIDING CRISIS INTERVENTION, SUPPORT SERVICES, EDUCATION AND ADVOCACY TO SURVIVORS, THEIR FAMILIES AND THE COMMUNITY

28 A Safe Place has been open to all residents of Rockingham and Strafford counties in New Hampshire for over 31 years. This year, A Safe Place provided FREE and confidential services to over 1,066 women, men, and children, giving 32,345 units of service - equivalent to \$970,350. Our services are available 24 hours a day, 365 days a year. A Safe Place provides assistance in filing temporary and permanent restraining orders and general legal advocacy. When necessary, staff meet "service users" at hospitals or other safe locations to offer our services. Safety is the first point of order for a Victim of Abuse. For women and children who are in imminent danger, we have a 16 bed confidential shelter where we provide a safe and empowering environment. Men who are in danger also have the availability of a safe and confidential location. This year A Safe Place served over 50 men. Over 7,000 middle and high school students participated in our Healthy Teen Relationship Program. Teen Dating Abuse is on the rise and our curriculum offers youth an opportunity to understand that relationships should be respectful and not abusive. People who come to us are often running for their lives and arrive with just the clothes on their back. A Safe Place supplies Food, Store, Pharmacy and Gas Cards to help our service users get back on their feet and take the next steps on their journey from victim to survivor. Peer-to-peer weekly support groups focus on helping women and their children heal from the trauma of violence. A Safe Place, along with three other non-profit agencies formed a concurrent group program, employing evidenced based international curriculum, for women and their children who witness abuse. Children who witness violence need a safe and secure place to heal. A Safe Place offers a stress-free home environment in which children can begin to relax, laugh, and play, experiencing a home that has peace at its core, not violence. A Safe Place is a participating member of the New Hampshire Coalition Against Domestic and Sexual Violence, a state-wide network of 14 crisis centers who work together to advocate for laws, develop and implement service delivery standards, and create a statewide safety net.
