Case Management is the coordination of services provided to children and their families that are designed to eliminate risk to the child and strengthen the family. This includes face to face visits with children, their caregivers and parents, coordinating services to assess and provide individual services to children and parents, and reports to the court. We served an average of 850 children a month through case management last year. We documented 100% monthly home visits for children in 9 of 12 months and reduced children in out-of-home care over 12 months for the 4th year in a row.

Adoption services are overlay services provided to children whose parents have had their rights terminated. These services include completing an in depth child study, child matching events, matching staffings, completing homestudies on prospective adoptive parents, and court reports. This year we held our largest adoption celebration event to date. We exceeded our adoption target for the 4th year in a row by sponsoring 71 adoptions compared to our goal of 63. We Contracted out adopt only MAPP classes to 2 community providers. We also increased services to support adoptive families and trained 50 families in preparation for adoption.

Out of home care services are an array of services that are available to children who are removed from the custody of their parents. Costs incurred in this program include the cost of placing children in licensed homes and facilities along with the cost of services to support them in these placements. Over the past year we were able to safely reduce the number of children in Out of Home Care from 471 to 398. The number of children placed in Out of Home Care for a period of longer than 12 months was also reduced from 198 to 173.
