Part V, Line 4	Description of Intended Use of Endowment Funds	The School's endowment consists of 45 individual donor restricted funds established for a variety of purposes. As required by generally accepted accounting principles, net assets associated with endowment funds are classified and reported based on the existence or absence of donor-imposed or legal restrictions. Endowment funds include invested gifts and assets of pooled income funds for endowment purposes. The Board of Trustees has interpreted state law as allowing the utilization of appreciation on permanently restricted assets unless explicit donor stipulations specify how net appreciation must be used. As a result of this interpretation, the School classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. The remaining portion of the donor-restricted endowment fund that is not classified in permanently restricted net assets is classified as temporarily restricted net assets until those amounts are appropriated for expenditure by the School in a manner consistent with the standard of prudence prescribed by state law. To satisfy its long-term rate-of-return objectives, the School relies on a strategy which emphasizes total return through both capital appreciation (realized and unrealized) and current yield (interest and dividends). Specifically, the primary objective in management of the endowment is maintaining liquidity and long-term capital growth, while preserving the purchasing power of the endowment. The School has invested in mutual funds, equity securities, and an alternative investment that target a diversified asset allocation that places a greater emphasis on equity-based investments to achieve these objectives within prudent risk constraints. The Board of Trustees adopted a policy of transferring 4% of the market value of investments to operations based upon a three year rolling average of all investments. The 4% transfer includes interest and dividend income earned on such investments for use in the general operating activities of the School. To the extent that investment income does not provide this level of support, net investment appreciation is appropriated for operations. In establishing this policy, the School considered the long-term expected return on its endowment. This is consistent with the School's objective to maintain the purchasing power of its endowment.
