Connecticut Legal Services provides civil legal representation and counseling to help low-income individuals (adults and children) and families obtain just legal solutions to serious life problems. We assist our clients to use the law to help themselves climb out of poverty, improve their lives, and build better futures for their children. Areas of specialty include domestic violence/family, homelessness/housing, public benefits, special education, elder, and disability law. During the 2008/2009 fiscal year, CLS advocates provided assistance to 5,508 low-income households consisting of 12,017 individuals, including 4,538 children. In addition, over 200 outreach/community legal education events were held throughout our service area, reaching over 10,000 individuals. Approximately 11,590 legal educational pamphlets were distributed at these events. During the 2008/2009 fiscal year, Connecticut Legal Services received a total value of \$192,054 in donated services to support the work described above.
