	TRANSITIONAL HOUSING Transitional Housing Program - Transitional Living Program provides stable, safe living accommodations and support services to homeless women and their children The program is designed to help women and families transition to self-sufficient living and permanent housing Case managers work with the women on issues such as employment, day care, life skills, education and financial assistance Youth Program Staff tailor specific services to the children in the program that include enrichment activities, educational, social and recreational opportunities 18 women and 30 children can be accommodated at a time and they are able to stay in one of the 18 apartments for up to two years Department of Social Services "Shelter Overflow" program - provides funding for alternative emergency shelter arrangements when local shelters are full DSS case managers invoice MSP when such an arrangement is needed and a check is issued either for a security deposit or a hotel/motel room This service is available for DSS clients statewide Rapid Rehousing Models - During FY 2009 MSP has played a role in two Rapid Rehousing demonstration projects The Rapid Rehousing Pilot Project - This project involved a collaboration between My Sisters' Place, the Salvation Army, The Coalition to End Homelessness and the Hartford Foundation for Public Giving MSP played a fiduciary role in the project by providing security deposits and first month's rent for families, who were referred to the project by area social service agencies and emergency shelters Through a grant obtained by MSP from the Lincoln Financial Foundation additional program dollars were made available to serve Families First, to extend the reach of this pilot program A total of 25 families were served in the course of the year Counselors in Shelters Rapid Exit - Another program, funded by the State Department of Social Services paid for counselors assigned to emergency shelters to work with families who can be quickly placed in new housing

	HOUSING COORDINATION PROGRAMMSP is a Fiduciary Agent - managing custodial accounts on behalf of a variety of individuals in the community who are not yet in a position to manage their own finances Clients include people exiting prison, mental health facilities or young adults who are leaving the child welfare system Alternative to Incarceration (A I C) - This program serves clients by providing rent subsidies, start up funds, furniture purchases, alternative housing options (such as Hotels) and food These men and women are Department of Mental Health and Addiction Services (DMHAS) clients, are considered at risk of becoming homeless and require the time to gain access to benefits or employment in order to continue their independent lives in the community Young Adult Services (Y A S) - the program provides housing support to Youth who are aging out of the child welfare system and are beginning to live alone in the community MSP acts as rep-payee for some of the clients and assists them in managing their funds through education and training Also part of Y A S is the Hilltop Program for youth which provides a transitional living environment for young people MSP holds their lease, pays their rent and other expenses related to maintaining an independent living arrangement The Bridge Program - a program that provides temporary assistance with rent provided in the form of a loan, for individuals with mental illness, who are at risk of becoming homeless We believe that we have one of the largest Bridge caseloads in the state, with 182 individuals being served This program provides assistance to individuals referred from CRMHC for assistance with housing Program provides individuals with rental subsidies based on their income using DMHAS formula Individuals are also provided with a security deposit loan which they are expected to repay on a monthly basis Rent Subsidy Program - This program provides security deposits and first month's rent for individuals, who are not mentally ill and who are referred to MSP by other social service agencies and emergency shelters Local Bed Housing Pilot - a program that makes funds available to individuals who are in hospitals or respite facilities Program provides rental subsidies, security deposit loans, and start up funds Hope Pilot - a program that makes funds available for individuals who are homeless and are not willing to be placed in a shelter or any other facility Individuals work with the outreach team and receive funds through MSP for Rental Subsidies and Security Deposits Housing First - a program that works with individuals who are waiting to receive RAP certificates MSP provides Security Deposit Loans and rental subsidies until they receive permanent housing through RAP Fuse- works with clients currently released from prison and are ready to integrate in the community through the Public Housing Sector Criminal Offender Re-entry Program (CORP) - is a program that makes funds available for housing and funds to start up a home for men and women who are being released from prison MSP pays for rent and other expenses on their behalf Women and Men's Support - a program that provides rental subsidies and miscellaneous housing support for individuals who are being released from prison MSP pays bills on their behalf
