Our teachers are licensed and experienced and many have been with the school for as long as 25 years. The school has won many prestigious awards for our Hebrew and general studies curricula. Our students have won prizes in the NYC Board of Education Science Fair having competed successfully with the best and brightest students in the public schools. Our 8th grade graduates are accepted by the finest Jewish, secular and specialized NYC high schools. Our students achieve above-average standardized test scores. Our school has a comprehensive library collection of Judaic and General Studies books enhanced by on-line computers.
