



Concerts & Programming - FCCA provides a wide array of performances throughout the year, including jazz, world music, classical, puppetry arts, visual-theatre, family programs with interactive arts workshops, and more. Our theatre seats 308 audience members, with removable seating risers to accommodate dances and banquets. Our gallery also serves as a venue for intimate concerts of 125 audience members. The garden serves as a location for free summer concerts with dance lessons, and festivals.

Exhibitions - Our Exhibition programs features on-going exhibits throughout the year, with exhibit turn-around approximately 4-6 times annually. Mainstays of the exhibition program include an annual FCCA Visual Artists' Member Show and an exhibition for the Lunar New Year. Salon Sundays, informal networking for artists and audiences, as well as periodic Studio Visits are part of the program.

Education - FCCA's Education Department offers in-school programs with teaching artist residencies, as well as tours, workshops & performances at Flushing Town Hall.
