THE URBAN SUMMIT HAD A TOTAL OF OVER 220 ATTENDEES, 122 ADVOCATES AND 93 GOVERNMENT OFFICIALS, INCLUDING 9 MAYORS AND 11 PUBLIC HEALTH COMMISSIONERS. REPRESENTATIVES FROM 15 FOUNDATIONS AND 20 NATIONAL ORGANIZATIONS ALSO ATTENDED THE EVENT. THE NATIONAL INSTITUTE WORKED FOR OVER A YEAR TO IDENTIFY URBAN CENTERS WITH PROGRESSIVE ELECTED OFFICIALS INTERESTED IN SUPPORTING COMPREHENSIVE REPRODUCTIVE HEALTH POLICIES TO PARTICIPATE IN THE URBAN SUMMIT. THE ORGANIZATION ALSO STRIVED TO ENSURE REGIONAL REPRESENTATION AND DIVERSITY WITHIN OUR OUTREACH TO POTENTIAL PARTICIPANTS, AND FOCUSED ON AREAS WITH THE STRONGEST BASE OF LOCALLY
